All rebates are subject to quality assurance inspections to insure rules were followed.
You must be 18 and a legal resident to participate.
One rebate per pool, per residence only
Hayward builders and their employees and relatives are not eligible to participate.

I understand this rebate is not a guarantee. If the temperature reaches 118 degrees farenheit or above on July 4, 2015 at the Phoenix Sky Harbor International Airport as reported to the NCDC/NOAA, I will receive a rebate check for the amount of my pool contract up to \$10,000. I am responsible for any federal, state, or local taxes associated with this promotion. This money will go to the Pool Owner as listed on the Pool Contract and cannot be used as a reduction off the price of the pool. All pools must be completed and paid for by June 3, 2015 in order to qualify for this promotion. An inspection of the paperwork and the pool may be required in order to collect this rebate. ## HAYWARD POOL “BEAT THE HEAT” PROMOTION

1. **How To Participate:** Promotion period starts 2/9/15 and ends 2/28/15. Purchase a new inground pool from an authorized, registered and participating Totally Hayward Pool (“THP”) Builder, including a Hayward brand pump and a Hayward brand filter, and at least one additional Hayward branded product from among those listed here:

- (1) Heater
- (2) Heat Pump
- (3) Controller
- (4) Cleaner
- (5) Salt Chlorinator
- (6) Two (2) ColorLogic® LED Lights

Subject to verification of all eligibility requirements, purchasers are sometimes referred to herein as “Participating Customers.” Only authorized THP Builders with physical locations in Arizona may participate. Your THP Builder must submit your signed contract, name, address of pool, phone number of participating customer, building permit, contract price, and the serial numbers of the Hayward products used to a designated Hayward website on or before 11:59:59 PST on March 8, 2015. Hayward is not responsible if Builder fails to submit all required entry materials as specified, or if computer, electrical, transmission, mechanical, or other error of any kind occurs during submission and processing. Pools must be fully installed and operational as of close of business June 20, 2015. Sponsor shall determine whether a pool is fully installed and operational in accordance with industry standards. Sponsor’s decision is final.

2. **Conditions for obtaining a refund:** If the maximum temperature at the Phoenix International Airport on July 4, 2015 (as reported to the NCDC/NOAA matches or exceeds the record temperature of 118 degrees (F) set on July 4, 1989, Hayward will rebate to Participating Customers the sum of \$10,000, subject to verification of Customer qualification (“Qualifying Customers”). The temperature in Phoenix, Arizona on 7/4/15 will be solely determined by the recorded temperature at the Phoenix International Airport (as reported to the NCDC/NOAA)]. (In the event a Qualifying Customer’s contract price for his/her pool was less than \$10,000, then Sponsor shall rebate only the contract price.)
3. **Payment Of Refund:** Sponsor and its agents will determine in their sole discretion whether the conditions for paying refund as outlined above have been met and will notify Qualifying Customers via certified mail. Qualifying Customers may be required to execute affidavits of eligibility and publicity releases and to return them to Sponsor on or before August 7, 2015, in order to receive refund. Sponsor shall have the right to inspect all building sites to verify pool construction.

All refunds will be in the form of a check payable to the name(s) of the Qualifying Customer on the THP Builder contract and will be shipped within 90 days of receipt and verification of submission. Qualifying Customers must pay applicable taxes, if any.

4. **Eligibility.** Promotion open to legal U.S. residents 18 years and older who own property in Arizona. Employees, directors and officers of Hayward Pool products and its subsidiaries, affiliates, advertising and promotion agencies and the immediate families of each are not eligible. Void where prohibited.
5. **Qualifying Pools.** This offer may only be made to consumers by authorized THP Builders with physical locations in Arizona. This offer is available only for new inground, residential pool installations physically located in Arizona. Commercial pools, re-furbished pools, after-market or retail sales do not qualify for this offer.  
  
This offer is only for new pool contracts signed between 2/9/15 and 2/28/15. Previous contracts are not eligible. Contracts pending but not fully executed as of midnight on 2/28/15 are not eligible.
6. **Advertising and Promotion.** Qualifying Customers consent to the use of their name and likeness in advertising and promotional materials for Sponsor and THP Builders in any and all media without further compensation except as may be required by law.
