George Bush Passes New Pool and Spa Legislation

H.R. 6-303to309, Title XIV-Pool and Spa Safety, otherwise known as the "Virginia Graeme Baker Pool and Spa Safety Act" has been passed by Congress and George Bush. After research conducted by the United States Government they have determined that after the date of December 19th, 2008 every "Public Pool and Spa" in the US must be up to code regarding this new Act. The increase of unintentional drowning of children age 14 and under has increased dramatically in the last 15 -20 years. Also the second leading cause of death in the US for children 14 and under is drowning. These facts are what seemed to be the deciding factor for Congress in July and George Bush in December. This new law will mandate Public Pools and Spa to have:

1. Vacuum Release Systems
2. Suction Limiting Drain Systems
3. Gravity Drainage Systems with Collection Tanks
4. Automatic Pump Shut Off

This new law also calls for residential pools to have barriers that will effectively prevent small children from gaining unsupervised and unfettered access to the pool or spa. Please be sure to read through this act thoroughly so that you are able to understand and to educate others on what this act is calling for. CAT Controllers strongly supports this act and plans to get more thoroughly involved with promotion of anti-entrapment safety both through education and through manufacturing of preventative products.
